Settlement – settlement regulations



Pricing and settlement currency: RMB

Margin system

- Trading margin, balance deposit (minimum balance requirement)
- Assets can be used as margin: offshore RMB, Domestic RMB, foreign currency, standard warehouse receipt
- Foreign currency benchmark: Middle price of CNY currency rate released by CFETS
- Discount rate: 95%
- Currency conversion: foreign currency*middle price*0.95

No liability settlement system


• The net amount on the same day of payment for all contract profit including loss, commission fee, tax, shall be paid in a lump sum.

Commission settlement system

- Oversea particular participants: Shall and only shall be appointed for settlement by one member.
- Oversea broker: Entrust exchange members or oversea particular broker to conduct transaction settlement.


Clearing — closed-loop operation Funds

Method of Handling	•	Deduct from USD account and increase the balance of RMB account, which will automatically transfer to INE.

Foreign Investor mustn't initiate any foreign exchange purchase and settlement requirement other than trading alone.

Trading loss can only be rectified by RMB

For foreign investor there will be imposed with no fund quota but position limit

Foreign investors may choose either use USD or RMB to exhibit their profits, each half year.
